



## CIRCULAR

The Executive Committee has approved and prescribed the following code of conduct to be followed in all SCBA Elections henceforth:

1. No campaigning of any sort should be permitted for any of the post after the debate for the Post of President and Hony. Secretary.
2. No candidate or his/her agent would offer any kind of allurements in the nature of any gift, feast or party during or prior to election.
3. Distribution/display of any handbill/pamphlets or any other campaigning material would not be permitted in the Supreme Court premises throughout election.
4. During election campaign SMS should be routed only through SCBA Office and a "Do Not Disturb" register be also created to enroll those Members of the Bar who do not wish to receive calls and SMS for the purpose of election campaign.
5. Each of the contesting candidates will be allowed to send maximum 4 SMSs to the Members of SCBA for the purpose of Campaigning from the date of announcement of election.
6. On the date of SCBA elections, no entry passes would be made for interns and law students and they would not be allowed to enter beyond check point in Supreme Court premises from the proximity entry.
7. It should be the duty of the Election Committee to ensure that during the elections no personal aspersions or remarks should be made against any of the candidates.


