### **OFFICE ORDER**

The said Executive Committee members also expressed gratitude for the time and efforts put in by the Chairman and members of the Special Committee and further resolved that intimation in regard will be sent to the Special Committee by the Ld. Vice President, Mr. Jitendra Mohan Sharma, Senior Advocate."
