## ENDEAVOURS TO ACHIEVEMENTS

### ✓ Welfare Schemes

**Group Life Insurance Policy :** The SCBA members have been provided Life Insurance Coverage (Natural or Accidental death) of Rs. 5 Lacs by IDBI Life Insurance Company Limited and the premium of the said policy has been paid from the donations made by SCBA members. **The SCBA have been able to generate more than Rs. 50 Lacs in the 'SCBA Advocates Welfare Fund A/c' which is sufficient to provide coverage to the members for the next year i.e. 2016-2017 also.**

**Group Health Insurance Policy :** The SCBA has also provided a Group Insurance Policy, providing Health Insurance coverage of Rs. 5 Lacs to SCBA members and also their family members at a very competitive rate.

**The SCBA has the coveted distinction of becoming the first Bar Association in the country to have a Group Life as well as Health Insurance Policy for its members.**

### ✓ Financial Health of SCBA

- This year Auditing of the SCBA Accounts were done, which was not done last year.
- This year physical verification of Fixed Assets is being carried out which is being done also done for the first time after many years.
- The Net Income of SCBA has also considerably increased from Rs. 87 lacs approximately for the year ending 30.11.2015 to Rs. 1.81 Crore approximately for the year ending 30.11.2016, which is an increase of Rs. 94 lacs approximately over last year.
- The Executive Committee decided to convert the SCBA account facility from Current A/c to Auto Sweep A/c. This decision resulted in an additional revenue of Rs.25 lacs approximately of interest income for the SCBA.
- New FDRs created for Rs 4.9 Crore approximately by converting unutilised balance in various SCBA Accounts. As a result, overall Interest on FDR increased by Rs 71 lakhs approximately this year in comparison to last year.
- The Executive Committee also found a serious financial irregularity this year, **all proceeds from the sale of Advocate Welfare Stamps (AW Stamps) were not being deposited in the SCBA account.** The Chartered Accountant confirmed that there is misappropriation of funds to the extent of Rs. 76,800/ which was noticed by the Executive Committee, proper steps were taken to ensure that this kind of irregularity is not repeated again.

✓ **Intellectual Pursuits**

The SCBA has started a lecture series titled "**Think Legal**", where eminent jurists and learned senior members of the Bar share their experience and knowledge with the bar members.

- First lecture of the said series was delivered by Mr. Ram Jethmalani, Senior Advocate on the topic of "**Role of the Bar in the present Judicial System**".
- A Lecture was also conducted on the topic of "**Cornellia Sorabjee - The First India Woman Lawyer**" who studied at Somerville College, University of Oxford. Mr. Fali S Nariman (Sr.) and Mr. Soli Sorabjee (Sr.) also shared their thoughts with all the members in the function.

**Ms. Nancy F.** Atlas, Senior United States District Judge, United States District Court, Southern District of Texas, Houston Division also shared her intellect with the Bar members on the topic of "U.S. Judicial Systems".

✓ **Being There For You**

**Special Counter for Lawyers during Demonetization:** Keeping in mind the inconvenience caused to the members during the demonetization period, a **special counter of UCO bank** was made operational at the SCBA meeting room. Earlier lawyers were standing in queues along with outsiders in the Supreme Court premises which was not befitting the prestige of SCBA. All banking facilities were extended at this special counter which benefitted thousands of members and is still helping the members in present.

✓ **Infrastructural Facilities**

- Seeing the rise in the number of lady colleagues, a renovated **Ladies Bar Room** was inaugurated to give them more space.
- A New Bar Room with all modern amenities has been constructed to allocate the extra space for the SCBA members. The new bar room will provide a proper place to its members where functions of 100-150 people can be arranged.
- Keeping in mind the paucity of space, the **Plaza Canteen** has been renovated with improved facilities and ambience.
- A new **Litigants Lounge/Canteen** has been inaugurated which provides better facility to the SCBA members as well as the litigants.
- The Supreme Court is now a **Wi-Fi** enabled premises.

The newly elected Executive Committee of Supreme Court Bar Association took charge on 15.12.2015, after the Annual Elections of SCBA, which was held on 11.12.2015. ## **AMENITIES TO THE MEMBERS OF THE BAR**

In our endeavour to provide better facilities to the Hon'ble Members of the Bar, the following steps were taken:-

✓ **Renovated Ladies Bar Room**

On 27.01.2016 Hon'ble Mr. Justice T. S. Thakur, Chief Justice of India inaugurated the newly renovated Ladies Bar Room in august presence of Hon'ble Mr. Justice Anil R. Dave, Hon'ble Mr. Justice Jagdish Singh Khehar, Hon'ble Mr. Justice Dipak Misra & Hon'ble Mrs. Justice R. Banumathi. We are grateful to Hon'ble Mr. Justice T.S.Thakur, Chief Justice of India who was very kind to allocate extra space for the Ladies Bar Room, keeping in mind the lack of space for the Lady Members of the SCBA. He also took personal interest in ensuring that the facilities and ambience of the newly renovated Ladies Bar Room are exemplary.

✓ **NEW WOODEN LOCKERS AT LADIES BAR ROOM**

In line with our efforts to give better facilities and infrastructure, new wooden lockers have been placed in the Ladies Bar Room.

✓ **New Bar Lounge**

The newly Bar Lounge is functional for members use after inauguration by the Hon'ble Mr Justice T.S.Thakur, Chief Justice of India, in the presence of all other Supreme Court Judges on 15.03.2016. The large numbers of eminent Senior Advocates namely Mr. Soli J. Sorabjee, Mr. K. Parasaran, Mr. Ram Jethmalani, Mr. M.N.Krishnamani, Mr. Kailash Vasdev, Mr. K. Ramamoorthy, Mr. V. Shekhar, Mr. Harin P. Raval, Mr. P.S. Narasimha, Mr. Shanti Bhushan, Mr. Siddharth Luthra were present. On this occasion the Chief Justice of India and other Judges shared their views and also eminent Senior Advocates spoke about Bar lounge. We are once again grateful to Hon'ble Mr. Justice T.S.Thakur, Chief Justice of India who was very kind to allocate extra space for the Bar Room, keeping in mind the lack of space for the Members of the SCBA.

✓ **The Litigants Lounge / Canteen**

The Hon'ble Mr. Justice T.S. Thakur inaugurated "The Litigants Lounge / Canteen" on 7th December, 2016. This will provide a much needed place for thousands of litigants, old and young - men and women - children - rich and poor- businessmen and workers - teachers and students - uniformed officers and un-uniformed employees - foreign visitors etc. etc.

For 66 years, we, the Bar and the Bench, perhaps overlooked their needs and we must remember that our Great Institution depends on them. The Bar is eternally grateful to the Bench, especially the Hon'ble Chief Justice of India for having given us the Bar Room/Lounge for the first time in 66 years.

✓ **Library Books**

I am happy to inform Respected Members that we have purchased new Bare Acts & 'Reference Books' on various law subjects and the same are now available in Library No. I & Library No. II for reference purposes.

Keeping in mind the need to have local laws available for SCBA members, purchase order has been placed to have local law journals for various States, which were not earlier available at the SCBA libraries.

✓ **Printing cost**

Acting on the request of the SCBA members the cost of printout taken from e-research Library/cubicle is reduced from Rs.10 per page to Rs.5 per page, while the printing cost of judgment is reduced to Rs.1/- per page.



✓ **Printer for Library-IV**

Keeping in mind the demand of the SCBA members for having a printer in Library-IV, new Laser Printer was purchased and installed in the Library-IV for members' convenience

✓ **Wi-Fi Facilities In SCBA Library**

Internet connections are upgraded for better speed and functioning in libraries etc. As a corrective measure, the plan has now been upgraded to a monthly rental plan of Rs.999/- per month, which will provide better bandwidth, more data at a lesser price. It was noticed that there were two Wi-Fi connections in Library-1. Due to demand of the SCBA members and so as to provide better access to online resources, 3 more Wi-Fi Internet connections were setup at Library No.1 and all are functional. Respected members can avail the aforesaid facilities in the following rooms:-

- A. Cubicle Room
- B. Text Room
- C. SCR Room

✓ **Utilisation of E-library funds**

The funds collected for E-library have been judiciously utilised by the present EC. Earlier 100 licences for 3 different softwares like SCC online, Manupatra were subscribed by the SCBA but out of those 100 licences only 20 were functional and in use for the last 1 year due to non-availability of Static IP in the library but payment was being made for all 100 causing 'wastage/unnecessary expenditure of SCBA' funds to the tune of 30 lacs.

The above issue was solved by having a discussion with the SCC Vendor and saved Rs. 6 lacs from last year and 6 lacs annually till the SCBA gets a static IP address.

The Executive Committee meeting and Special Committee after discussion resolved that

- The SCBA will not pay a cheque of Rs 23 approximately since only 20 out of 100 connections have been used. The fact that only 20 out of 100 connections were used was also agreed by Mr Sanjay Kapoor and therefore the payment was reduced to approximately Rs 1.2 lacs for the entire usage of 1 year. The annual cost had we paid a cheque of Rs 23.5 lacs to SCC would have worked out to be 7 lacs approximately per annum excluding the free year and 6 lacs including the free year. In any case the SCBA at least saved Rs 5-6 lacs due to the negotiations.
- It was further negotiated that on a pro rata basis payment of Rs 1 lac approx. will be made for 20 connections for a period of 1 year starting from 1st July 2015 to June 2016

**Note** - This saved the bar approximately Rs 5-6 lacs for this year upto June 30 and will also help in saving another Rs 5-6 lacs from 1st July to 30 June 2017 till we get a static IP address

- The agreement will be kept in abeyance and will only come in to effect after the SCBA is able to get a static IP address, till then the SCBA will pay only for the 20 connections that are being used and that too on a pro rata basis.

There are certain pending issues which will be amicably resolved by discussions with respective software vendors.

✓ **Wi-Fi Facilities In New Lounge**

2 Wi-Fi connections for internet connectivity have also been installed for the convenience of the bar members along with an LED T.V. and Cable Connection.

✓ **Newspaper & Magazine**

Due to members demand, subscription numbers of newspapers have now been increased. And also five copies of magazines namely Tehlaka, India Today & Outlook have been subscribed to, for members' convenience

✓ **Improvements in Plaza Canteen**

Following works has been done in the Plaza Canteen for improving the facilities and ambience;

- New Furniture
- Extra Tandoor
- Table Cloth
- Waiters and House Keeping Staff
- Vegetarian Pool
- Fresh Food

Along with the above improvement, pursuance to the instructions of Hon'ble Chief Justice of India, further expansion of Plaza Canteen in Supreme Court premises is going on, Advocates' Lounge has been merged with canteen for providing more sitting capacity, better ambience and proper lighting facilities.

✓ **Extension of Plaza Canteen**

Keeping in mind the paucity of space in the Plaza canteen, the same has been extended for creating more sitting capacity and providing new look and ambience to the canteen, along with this, the false ceiling of the plaza canteen was also changed so that more fans can be installed. During the Summer Vacation, the following works were done in the Plaza Canteen for improving the facilities and ambience;

- The entire canteen now has a newly installed air conditioning system for better ventilation and cooling.

- After the extension of the Plaza Canteen, the sitting capacity increased from 38 tables to 50 tables i.e. from 152 chairs to 200 chairs.
- Further standing capacity has been increased from 6 tables to 9 tables which can accommodate approximately 24 persons to 36 persons.
- One new washbasin has been added.
- 4 new Air conditioners were installed doubling the cooling in the Plaza Canteen.
- As demanded by all respected members, a separate space earmarked for Interns, Clerks and Litigants.

We express our heartfelt gratitude, to Hon'ble Mr Justice T.S. Thakur, Chief Justice of India who took personal interest in ensuring that the facilities and ambience of the Plaza Canteen are exemplary.

✓ **Renovation of C.K. Dapthary Canteen**

Canteen at C.K. Dapthary Chambers Block has been renovated and restructured for members' convenience during summer vacation and the catering contractors of canteens of M.C. Setalvad chambers block and C.K. Dapthary chambers block were changed to provide better services/food to Members of the Bar at competitive prices.

✓ **Renovation of Lunch Room Adjacent To Library No.2**

The Lunch Room was renovated giving it a new look and fresh appearance during summer vacation. The flooring of the said room was changed and white wash had been done. Efforts were being made for additional improvements and facilities in the lunch room.

✓ **Verification for Forms of Place of Practice of Advocates**

Bar Council of India Certificate And Place Of Practice (Verification) Rules, 2015 vide Gazette Notification issued instructions of all State Bar Councils to verify the place of practice of Advocates of their concerned Bar. This was a herculean task and the undersigned with active support and cooperation of Dr. Sandeep Singh Joint Secretary, Mr. Amit Anand Tiwari, Treasurer and Mr. Anurag Pandey, Joint Treasurer, verified more than 5000 forms of the member Advocates even during summer vacation.

✓ **Locker status**

Members are informed that there are 436 applications for allotment is locker is pending consideration and 217 is lockers are available in the parking lot of C.K. Dapthary Chambers Blocks. The SCBA has issued 59 Lockers to the Members as per the seniority.

✓ **Separate UCO Bank Counter**

Keeping in mind the inconvenience caused to the members during the demonetisation period, a special counter of UCO bank was made operational at the SCBA meeting room. Earlier lawyers were standing in queues along with outsiders in the Supreme Court premises which was not befitting the prestige of SCBA. All banking facilities were extended at this special counter which benefitted thousands of members and is still helping the members in present.

✓ **Installation of E-kiosks and interactive Screen**

For member's convenience, Supreme Court registry installed e-kiosks and interactive screens at convenient places, Supreme Court Compound so as to access the Supreme Court Website/Cause List/Case Status etc.

✓ **Improvement of Creche -**

Under the direct push of Hon'ble Chief Justice of India and in monumental step, Child Care Creche (Creche) was made operational from 04.11.2015 with 3 toddlers. The existing crèche was facing several problems which were looked into and the Executive Committee ensured that better services and hygiene is maintained in Creche. The Hon'ble Supreme Court of India also passed the below order in the matter relating to formation of creche in Supreme Court on 05.09.2016 and the Executive Committee is ensuring that the SCBA comply to the directions passed by the Hon'ble Supreme Court.

*We have considered the letter of the Registrar dated 29th August, 2016 addressed to Shri Sidharth Luthra, learned Senior Counsel appearing for the Supreme Court of India through Secretary General. We have also heard Shri Gaurav Bhatia, Hon. Secretary, Supreme Court Bar Association.*

*For the present, we direct that the steps/measures indicated in the letter dated 29th August, 2016 of the Registrar be forthwith implemented and the result of such implementation, particularly, in terms of the better utilization of the facility and improvement in condition of hygiene, etc. be laid before the Court at the end of three months from today. We also call upon the Secretary General of the Supreme Court of India to consider the feasibility of providing the services in the creche free of charge. We also request the Supreme Court Bar Association to consider the feasibility of supporting the facility from its funds, particularly, in the context of what is going to be an enhancement of such facility once the new building is made ready. We further direct that the benefit of the crèche facility be made available to the children of female registered clerks engaged by the Advocate-on-record(s)/Senior Advocate(s)."*

✓ **Standard Operating Procedure framed for medical emergency**

For the convenience of the member's visiting the CGHS (within Supreme Court premises) wherein they are attended by Dr. Shyama Gupta, if any member observed to be in critical condition, CGHS In charge has been requested to immediately inform the Hony. Secretary of SCBA, Joint Secretary SCBA and also to SCBA Staff members. The Standard Operating Procedure (SOP) has been framed after discussion with Dr. Shyama Gupta. This will ensure that any member in critical condition required to be taken to the hospital, will mandatorily be accompanied by a lawyer colleague or somebody from the SCBA office.

**ISSUES RAISED WITH HON'BLE CHIEF JUSTICE OF INDIA AND SECRETARY GENERAL, SUPREME COURT OF INDIA**

✓ **Chamber for members**

The Appu Ghar Complex was inaugurated in the year 2010, more than 500 chambers were promised. Even after 5 years have passed we didn't know the number of chambers that were coming up. The Executive Committee requested the Secretary General on 13.01.2016 that all members of Supreme Court Bar Association will be grateful if a written confirmation of the number of chambers that are coming up at Appu Ghar complex may be provided.

The Executive Committee also had a meeting with Hon'ble Chief Justice of India on the issue pertaining to allocation of Chambers at Appu Ghar Complex, during the course of the meeting, SCBA was informed that the Pragati Maidan complex will have parking for 1842 cars, 250 chambers approximately for lawyers with a provision for each chamber to be jointly allotted to two lawyers. We were also informed that there will be 168 consultation chambers and a Litigant hall, with an area of approximately 4000 sq. feet.

The applications for allotment of chambers were last invited in the year 2004. We took up the issue and as assured by the Secretary General of the Supreme Court of India fresh applications for chamber allotment would be invited by the registry of the Supreme Court in the first quarter of 2017

✓ **Registrar Court No. 2**

Keeping in mind a limited capacity to accommodate more than 50 lawyers at any given point of time in Registrar Court No.2, whereas, on average more than 100 matters are listed on a daily basis. It has been noticed that there is no space for the lawyers to enter the Court Room, which is causing great hardship to all lawyers. In this regard, I requested the Secretary General by letter dated 03.02.2016, if possible the same should be moved to a more spacious Court Room which can accommodate more lawyers.

✓ **Listing Matters**

Issues relating to Filing and Registry were discussed with Shri Ravindra Maithani Secretary General for immediate consideration and redressal. The issues which were discussed were:

- Intimation regarding fresh matters may be given well in time.
- Printing on both sides of the paper book should be allowed.
- All the defects may be pointed out to the concerned Advocate-on-Record in one go.
- Only one paper book with original may be taken during initial filing, before the defects are cured. All three requisite paper books may be directed to be filed after curing all the defects.
- Urgent matters should be numbered within two hours after showing the urgency to the Addl. Registrar, in charge of filing.
- Defect curing counters to be increased and creation of separate counters for female advocates.
- Earlier practice of only charging court fees and no charges for caveat should be reconsidered.

✓ **Display Board**

SCBA requested the Registry to install a display board near the stairs leading to Court Room No.4 and near the cafeteria, at first floor for convenience of members. The Secretary General assured that this will be done.

✓ **Entry of lawyers with proximity cards from gate "F"**

The SCBA taken up issue of lawyers and clerks with proximity cards to use gate F on foot since large number of them use the metro and get down at the Pragati Maidan Metro station and walk in to the Supreme Court, with their files and bags. This will cut down their walking time substantially. Presently only Registry staff is allowed to use the same gate. The Secretary General given an assurance to look into the same for the convenience of the members. The matter is under consideration before the Security Committee.

✓ **Sales Counter For Supreme Court Reports (SCR)**

In response of our letter dated 26.04.2016, the Registry accepted our request and opened a sales counter for Supreme Court Reports (SCR) and some other related journals/ publications of Government of India, at Counter No.42 & 43 in the New Reception Block from 3rd October, 2016.

Sharma (9654986515).

SCBA granted a sum of Rs.1,00,000/- to Mr. D.D. Sharma, Advocate and Member SCBA towards medical assistance

One of the Advocate was suffering from cancer, keeping in mind the urgency and need, the Executive Committee has resolved to initially release Rs.50,000/- (Rupees Fifty thousand only) to the towards medical assistance and the same has been disbursed to her account through RTGS.

### **IMPORTANT RULES & GUIDELINES TO BE FOLLOWED FOR THE ENSUING ELECTION 2016-2017**

#### **RULE 17: Election**

The Office Bearers of the Association shall be elected by Secret Ballot and the other members of the Committee shall be elected by secret ballot by single distributive votes at the Annual Election. No Office Bearers or member of the Committee shall be eligible to hold any office for more than two consecutive years. Canvassing in any form on the date of polling is prohibited.

#### **RULE 17-A : Election Committee**

Election to the Association shall be conducted by an Election Committee of 3 members to be nominated by the Executive Committee of the Association. The members of the Election Committee shall not participate in the election, except casting their votes. The Election Committee shall exercise full and absolute control over the election and its decision shall be final and binding.

#### **RULE 18 : Eligibility of Member to Contest and Vote at Elections.**

- l) No members of the Association shall be eligible to contest for any post of the Association unless:-
- (a) He/she paid his/her subscription, payable annually, on or before the last day of February of the year in which the elections are to be held.
- (b) He/she pays by Cheque/DD/Pay Order alongwith his/her nomination form the sum mentioned against the post for which he/she is seeking election which follows:-

<b>President</b>	<b>: Rs. 5000/-</b>	<b>Vice-President</b>	<b>: Rs. 4000/-</b>
<b>Hony. Secretary</b>	<b>: Rs. 3000/-</b>	<b>Other Office Bearers</b>	<b>: Rs. 3000/-</b>
<b>Senior Member</b>		<b>Member Ex. Committee</b>	<b>: Rs. 1000/-</b>
<b>Ex. Committee</b>	<b>: Rs. 2000/-</b>		

Members whose nominations are rejected on scrutiny and/ or who withdraw their nominations by withdrawal date will be entitled to a refund of the above amount.

I-A The aforesaid Rule has to be read along with the resolution of the General Body passed on 28th September, 2004 which is extracted herein below:-

**"He/She must have five years standing at the Bar for contesting for the post of the Office Bearers and three years standing at the Bar for the post of Executive Member. Seniority will be from the date of enrolment as Member of Supreme Court Bar Association."**

- II) No members shall be eligible to cast his/her vote at the election unless:-
- (i) He/She is in possession of Identity Card at the time of casting his/her vote and shows it on demand, if so required.
  - (ii) He/She has paid his/her subscription by or before the **LAST DAY** of February of the Calendar Year in which the elections are being held and is **NOT IN ARREARS ON ANY ACCOUNT**.
  - (iii) A member who is in arrears of his/her subscription or any dues to the Bar Association will not be eligible, to propose or second the candidature of any members to any of the post. Such member shall not be entitled to contest the election.
  - (iv) Non-Active Members and Associate Members shall not have right to vote.

**NOTE :-** The aforesaid Rule has to be read along with the resolution of the General Body passed on February 18th, 2005 which is extracted herein below:-

**RESOLUTION NO. 18-III :-**

"A member who exercise his right to vote in any year in any High Court or District Court Advocates'/Bar Association election shall not be eligible to contest for any post of the Association or to cast his/her vote at the election. Every member before casting his/her vote shall in the prescribed form give a declaration that he/she is not voting in any other election of any High Court/District Court Bar Association. Provided, however, that if such a declaration is found to be false, it shall entail automatic suspension of the member giving such false declaration from membership of this Association for a period of three years."

The SCBA has prepared a list of Voters based on the questionnaire/permanent declaration made by the members. Only such members whose names are included in the final voters list shall be entitled to vote, contest, propose and second any candidate in SCBA Election-2015-2016.

**RULE 18-A :** A person who becomes a member of the Association after 15th January in a Calendar Year will not be entitled to take part in any elections held in that calendar year in any manner or to vote thereat or to stand for election or propose or second any member to the Committee or any office of the Association thereat.

**RESOLUTION DT.14.10.2014 PURSUANT TO RULE 39 :**

2. The Election Committee has also finalised the norms of the nomination paper and declaration in terms of amended Rule 22 to the following effect:

**"I,..... declare that I have not held the post in question for 4 years in my whole life time as member of Executive Committee of this Association as per amended Rule in terms of Rule 39 (as amended in General Body Meeting dated 14.10.2014)."**

Resolved that no member of the Bar shall be eligible to hold any one post for more than 4 years in his/her life time.

---

## **GUIDELINES FOR THE ELECTIONS, 2016-2017 OF THE SCBA.**

1. A candidate may file upto 2 nomination papers for a post. A nomination paper/set of nomination papers must be accompanied by a D.D. / Local Cheque towards deposit as per Rule 18 given overleaf. Failure of the candidate to pay the deposit alongwith the nomination paper(s) will make the nomination invalid. Nomination will only be valid subject to encashment of D.D./ Cheque. Cheques/Draft may preferably be of UCO Bank, Supreme Court.
2. A candidate shall be proposed or seconded only by members whose names are included in the final voters list.
3. NO voter shall propose or second more than one candidate for a post.
4. Nominations may be filed for more than one post by a candidate, provided each such nomination is accompanied separately by the deposit as specified in Rule 18 and complies with other formalities. However, a candidate can contest for only ONE POST.
5. A candidate who has filed nomination for more than one post shall withdraw, nominations for post/posts except the one which he/she intends to contest, within the time specified for withdrawal and failure to do so shall disqualify him/her from contesting the election for any of the posts and his/her deposit(s) shall be forfeited.
6. Candidates whose nominations are rejected on scrutiny/and/or those who withdraw their nominations by the last date of withdrawal will be entitled to refund of the deposit amount.
7. It will be the sole responsibility of the candidate to see that his/her nomination are properly filed, duly proposed and seconded by the members whose names are included in the final voters list with their signatures. The office will not be responsible if the form is found to be incomplete in any respect.
8. All voters must be in possession of Identity Card and produce the same at the time of issue of Ballot Paper and whenever required by the polling personnel.
9. Contesting candidates will be supplied one copy of voter list FREE at the time of filing nomination form. For extra copy, Rs. 100/- will be charged.
10. There should be no campaigning, distribution of hand bills/ pamphlets either in the Bar Association premises or in the designated polling area on the date of poll and it shall be the responsibility of a candidate to ensure that his/her agents conduct themselves in a manner befitting the dignity of the Bar of the Apex Court.
11. Any candidate or his/her agent found violating guideline 10 or obstructing any voter from exercising his/her right to vote will render that candidate liable for disqualification.

3. Election Committee will ensure that the voting arena is free from canvassing. In this regard, it is notified that carrying of any material in any form either by the candidate/voter/supporter is the premises of the Supreme Court is prohibited, and all the candidates and their supports should desist from crowding the entry to the voting arena and co-operate with the Election Committee in this regard.
4. The Members on election duty shall be authorized to verify the identity of the members entering the voting arena by production of their photo Identity Cards preferably issued by SCBA. The voters are requested to kindly co-operate.
5. All the Hon'ble Members of the SCBA are requested to fully cooperate with the Election Committee and facilitate smooth and efficient conduct of the election.

**SIGNIFICANT ACCOUNTING POLICIES**

1. The accounts are prepared on a going concern basis as per the historical cost convention.
2. **Recognition of Income & Expenses**
  - a. Income from License Fees, Bank Interest and Cause list are accounted for on accrual basis.
  - b. All other incomes are accounted for on receipt/cash basis.
  - c. Expenses other than audit fees and salary have been accounted for on cash basis; accordingly bills received but pending approval by the Executive Committee to the extent of Rs. 12, 59,274/- has not been booked in the books of accounts.
3. **Fixed assets**

Fixed assets are stated at cost less depreciation. Cost includes original cost of acquisition including incidental expenses related to such acquisition and installation.
4. **Depreciation**

Depreciation on all fixed assets is provided on written down value method at the rates and in manner prescribed under income tax act 1961 and the rules made there under. Depreciation on asset purchased through specific donation has been charged from the date they were put to use. Depreciation on such assets has not been charged to Income & Expenditure account; instead it has been set off against the donation received specifically.
5. **Accounting for Donation**
  - a. Donations received for purchase/acquisition of specific asset are accounted for under head "Donation for Fixed Assets" and shown in the Balance Sheet.
  - b. Donation received for meeting out any specific object or events are reduced from related expense or accounted for as Income after completion of such object event.
6. **Bank Reconciliation Statement**

Cheque prepared but not issued to the vendors or not presented for payment older than three months amounting to Rs. 39, 51,077/- have been reversed in the books of accounts.

## NOTES ON ACCOUNTS

1. Fixed Asset Register has not been maintained ever since and physical verification of fixed assets has never been carried out. Therefore complete details of fixed assets along with their respective values have not been reconciled with the books of account. In absence of details of obsolete \ discarded fixed Assets, provision for the same could not made be in the books of account.
2. Contingent liabilities not provided for in respect of: Legal cases are pending in various courts. Liabilities for such cases have not been ascertained, pending final judgment of the Court.
3. Gratuity and leave encashment is paid to employees at the time of retirement and accounted for on cash basis. There is no accounting policy for maintaining provision in respect of gratuity and leave encashment.
4. An embezzlement of cash committed by some employee of Association came to the notice of Executive Committee during 2006-07. The matter is subject to police investigation and pending final judgment of the Hon`ble Court.
5. Grant in Aid received from Government of India – In 1999-2000, Grant in Aid was received from Government of India for the purpose of construction of Golden Jubilee Auditorium to mark the Golden Jubilee celebration of Supreme Court of India Since the construction of the auditorium has not commenced the said grant has been put into the fixed deposits (with scheduled bank) and interest earned thereon has been considered as liability and added to the original amount of the Grant.  
Association is pursuing this matter with the Government of India, for extension of time limit allotted for the utilization of said grant. However Ministry of Law and Justice (Department of Legal Affairs) vide its letter No F. No. B. 13017/4/199-Admn III (LA) Date 12th July 2012 & 11 th September 2012 has advised the Association that the said grant amount be surrendered to the Government of India along with interest accrued thereon.
6. The Association has not registered itself under the ESIC act and hence no deduction or contribution being made under ESIC.
7. Though the TDS has been deducted and deposited regularly, the TDS on salary has not been computed and hence no deduction and deposit has been done.
8. Association has been granted registration u/s 12 AA of Income Tax 1961 vide certificate No S-2654/99/67. Association has claimed its income as being utilized for charitable purpose and therefore not made any provision for income tax (current & deferred) in its books of accounts.
9. Previous year figures have been regrouped or rearranged wherever considered necessary.
