

Wednesday, 08.05.2024 (end of the day)	Final voters list will be displayed on the Notice Board of SCBA and on the website of SCBA. <ul style="list-style-type: none">Office shall intimate all the members by SMS regarding publication of Final Voters List.
Thursday, 09.05.2024	Nominations for various posts may be filed by the members whose names appear in the voters list. <ul style="list-style-type: none">Names of both proposer and seconder must also appear in the voters list
Friday, 10.05.2024	Draft list of candidates shall be displayed on the Notice Board and on the SCBA website. <ul style="list-style-type: none">Office shall intimate all the members by SMS regarding Draft list of candidates.
11.05.2024	Objections/Withdrawal to the nominations may be submitted in the office of the SCBA. <ul style="list-style-type: none">Immediately upon receiving the objections to the nominations/withdrawal if any, the same shall be notified by the office of SCBA to the concerned candidate(s).


