CIRCULAR

The Supreme Court Bar Association to assist members in securing general medical health insurance had commenced taking group insurance policy with members contributing the premium for individual insurance covers which suited them. These are annual policies. The present policy is valid upto 13th August.

This year the Executive Committee undertook the task for continuing the policy. The initial premium quoted by the After higher. substantially Insurers was negotiations the terms for the continuance of the Group Medi Claim Policy have now been settled. The terms of the present policy are substantially the same as the premium However the benefits have been applicable earlier. negotiated and improved upon and are as follows -

- The premium covers family members who are over (i) age of 70 years without the required medical checkup. The premium for such insurance is substantially less.
- The normal premium for an individual taking a (ii) policy for Rs. 5,00,000.00 is far higher than the negotiated rates.
- Existing diseases are covered. (iii)
- No medical checkup for any beneficiary. (iv)
- All terms of the previous policy will apply to the (v) new policy.
- Insurance cover available after age 70 till 85 (vi) without medical checkup - there is no such policy under normal conditions.
- The policy covers all treatment in case of an (vii) infection by the corona virus.

When we started the process for renewing the policy in the month of July the insurance company gave a quotation for renewal the policy in the sum of ₹ 1,75,00,000.00 (Rupees One Crore seventy five lakhs)plus GST. After prolonged negotiation and the kind intervention of Sri Tushar Mehta,
