Respected Members are informed that the **Parking Stickers for 2022** will be available in the SCBA office from **Friday, 6th May, 2022.**

After **30th June, 2022, only** those vehicles having valid parking sticker-2022 will be allowed to enter the Supreme Court premises. Therefore, respected members are requested to apply for the Parking Sticker-2022 to avoid any inconvenience. The rates are as follows:

- For the first sticker for four wheeler vehicles - Rs. 700/- per vehicle.
- For one additional sticker - Rs. 1000/-.
- For Senior Advocates Rs. 2500/- first parking sticker.
- For one additional sticker - Rs. 3000/-.
- For two wheelers and vehicles driven by specially abled people Rs. 250/- per sticker.

THE CAR PARKING STICKERS ARE BEING ISSUED ONLY TO THOSE MEMBERS WHO HAVE PAID SUBSCRIPTION AND CLEARED ALL OTHER DUES OF SUPREME COURT BAR ASSOCIATION, AS ON DATE.

MEMBERS ARE ALSO REQUESTED TO GIVE REQUISITION FOR CAR PARKING STICKERS ON THEIR LETTERHEADS ALONG WITH PHOTOCOPY OF REGISTRATION CERTIFICATE OF VEHICLE & REQUISITE CHARGES MENTIONED ABOVE.
