Those members not having Proximity Card and also all existing Proximity Card holders will also have to submit fresh applications online on the link available on the home page of Supreme Court website under the heading **Proximity Card**. In case of any technical difficulty on the portal, users/applicants may avail of the Help Desk service available from 10:00 AM to 6:00 PM on all working days of the Registry on the following numbers:- (i) 011-23116565 (Extn. 6565) (ii) 011-23116566 (Extn. 6566);

Some members were complaining that they were facing problems in submitting Proximity Cards online on the Supreme Court website. We had requested the Registry to provide two staff from the Registry along with computers to help members in submitting Proximity Card online. Supreme Court Registry has accepted our request to provide dedicated Facilitation Desk in the air-conditioned Waiting Area, adjacent to the Plaza Canteen where Registry staff will help members in filling application for Proximity Card from Monday, 23.05.2022 and the Facilitation Desk will be operational on and from Monday, 23rd May, 2022 from 10:00 A.M. to 1:00 P.M. and 2:00 P.M. to 4:00 PM on all working days of the Registry.

It is however requested that members who are computer savvy do it online on the Supreme Court website so that the Facilitation Desk could be used by the members who are facing problems to apply for Proximity Cards online themselves.

Those Members who are facing difficulty in submitting online proximity cards are requested to bring the following documents for filling up Proximity Card application in the Facilitation Desk in the air-conditioned Waiting Area, adjacent to the Plaza Canteen where two Registry staff would be there to help the members:-

CIRCULAR

Preparatory to launch of the new Access Control System (ACS) and with a view to facilitate users (including existing proximity card holders) to register themselves and apply for new Proximity Cards online, the Proximity Card Registration Portal has been activated on and from 07.05.2022 on the Supreme Court website.

A user manual to facilitate all users/applicants to register themselves and thereafter submit online application(s) in their respective category will also be available on the portal.

Upon their online submission, all the applications will be automatically forwarded to the respective verifying authorities, who shall duly verify and forward the applications online to the Registry, for further process. As and when the new proximity cards are ready, the respective users/applicants shall be duly notified and they would be required to collect the same personally from the designated counter(s);

In case of any technical difficulty on the portal, users/applicants may avail of the Help Desk service available from 10:00 a.m. to 06:00 p.m. on all working days of the Registry on the following numbers:- (i) 011-23116565 (Extn. 6565) (ii) 011-23116566 (Extn. 6566);

The existing proximity card holders are also required to register themselves on the said portal and submit fresh applications online.
