CIRCULAR

The trial run and security audit of the new Parking Management System for the Basement-II parking under the D Block, Additional Building Complex will commence on and from 16.06.2022.

In this regard, all concerned may note the following:

- 1. On all working days, self-driven cars having valid SCBA stickers (Main Campus) may also enter through Gate No.3, following prescribed security checks and through D Block entry ramp and be parked in the designated parking slots in IInd Basement under the D Block.
- 2. Entry of such vehicles, on first-come-first-serve basis, at the Gate No.3 shall be permitted till the parking capacity of Basement-II parking under D Block is achieved.
- 3. Occupants will be required to display their respective proximity card/photo entry pass to the security personnel deputed at the Gate.
- 4. Signages have been put up at various points to guide the vehicles from the Gate to the said parking area, as well as to guide the occupants from the parking area to the Main Campus.
- 5. Occupants, after parking their vehicles in the IInd Basement, may use the walkway connected with the Litigant Tunnel, to reach the Main Campus. It may also be noted that utility services like restrooms etc. are not available in the basement areas.
- 6. Cars parked in IInd Basement under D Block, Additional Building Complex will have to exit the parking latest by 7:00 PM.
