## **CIRCULAR**

Respected Member,

This is to inform you that from Monday, i.e., 22.03.2021 onwards COVID-19 Vaccine will be administered between 10:00 AM to 4:00 PM to the eligible member/ family on a First Come First Serve basis to a maximum of 100 people per day at Delhi Government Health Centre, Opp. UCO Bank, Supreme Court Premises, New Delhi. Eligible member/ family are requested to carry any one of the following photo ID documents:

- Aadhar Card
- Electoral Photo Identity Card (EPIC)

This COVID-19 vaccination camp is organized on a voluntary registration basis and has been initiated by the SCBA as a facilitator and as per the Guidelines issued by the Government of India.

Further, members are also informed that it would be advisable to get the vaccine in a proper hospital as we do not have all the medical facilities required in a full-fledged hospital. We have basic medical facilities and we will be keeping a fully equipped ICU van as a standby during this vaccination camp for any emergency.
