CIRCULAR

I am happy to inform all our members that 3 Oxygen Concentrators of 10 Litre Capacity with >93% saturation have been gifted by Mr. Prashant Kumar, President, Bar Association of India to the Supreme Court Bar Association. The Executive Committee thank him for his generosity.

The Executive Committee has decided to offer the aforesaid Oxygen Concentrators to its members on the following terms:

1. It will be supplied to the needy members and their immediate family on First Come First Serve basis;
2. In case of many applications, it would be sole discretion of the Executive Committee to provide the Oxygen Concentrator to the much needy member.
3. The member would undertake to be totally responsible for collection, transportation, safe keep and return of the Oxygen Concentrator including the required sanitisation of the Oxygen Concentrator at the time of collection and return.
4. A cheque of Rs. 1,00,000/- would be submitted by the member while taking the Oxygen Concentrator. The said cheque will not be encashed and will be returned at the time of returning the Oxygen Concentrator by the member.
5. As the resources are limited, members are requested to return the Oxygen Concentrator preferably within a week unless advised by doctor and approved by the Executive Committee for retaining the same for a longer period.
6. The Executive Committee would not liable for any claims with regard to the said facilitation as the same is only an emergent service provided to the members of SCBA.
7. The conditions in the undertaking are put by Executive Committee to ensure that the facilities can be availed by large number of members in these critical times.
