The vaccination Camp is resuming from Monday, i.e., **14**<sup>th</sup> **June 2021**, for the age group of 18-44 years for all members and their families at Delhi Government Health Centre, Supreme Court Premises.

## **FOR AGE GROUP OF 18-44 YEARS**

- Vaccination will be administered to <u>50 persons per</u> <u>day</u>.
- 2. On Monday & Tuesday, i.e., 14.06.2021 & 15.06.2021 only those members will be vaccinated whose requests are pending with SCBA.

## **FOR AGE GROUP OF 45 YEARS AND ABOVE**

- 1. Walk-in vaccination drive will continue in the same manner as it was going on earlier, i.e., First Come First Serve basis.
- 2. Number of people to be vaccinated per day is now **limited to 50**.
- 3. Members should carry any one of the following photo IDs
  - i. Aadhar Card
  - ii. Election Voter ID Card
  - iii. PAN Card
  - iv. Passport
  - Timing of vaccination: 1:30 PM 4:00 PM on all working days, i.e., from Monday to Friday except on any national/Gazetted holiday.

Further, members are also informed that it would be advisable to get the vaccine in a proper hospital as we do not have all the medical facilities required in a full-fledged hospital. The fully equipped ICU Ambulance van which was kept as standby for any emergency during the earlier vaccination camp is not available for the members due to sharp rise in Covid cases in and around Delhi. Though it is not mandatory, however, we also do not have the paramedics for assisting the members in checking the blood pressure and blood sugar as was available last time.

The Executive Committee prays for the safety and good health of its members and requests everyone to follow Covid Protocols and co-operate in the vaccination drive.
