## CIRCULAR

*Respected Member*

You are requested to apply for the Parking Sticker-2020 latest by **Saturday, 24<sup>th</sup> July 2021** at SCBA office to avoid any inconvenience. **After 31<sup>st</sup> July, 2021**, only those vehicles having valid parking sticker-2020 will be allowed to enter the Low Security Zone of Hon'ble Supreme Court. Further, till 31<sup>st</sup> July 2021 those vehicles having 2019 stickers will be allowed to enter the Low Security Zone only if applied for 2020 stickers. The 2020 car Stickers would be valid for the entire 2021. The rates of Parking Stickers are as follows:

<b>PARKING STICKER RATES</b>	<b>AMOUNT In Rs.</b>
First Car Parking Sticker	<b>Rs.700/-</b>
Second Car Parking Sticker	<b>Rs.1000/-</b>
Car Parking Sticker for Sr. Advocate	<b>Rs.2500/-</b>
Second Car Parking Sticker for Sr. Advocate	<b>Rs.3000/-</b>
For two wheelers and vehicles driven by specially abled people	<b>Rs. 250/-</b>

Note: In case a member changes his vehicle a new sticker would be given @ Rs.700/- after returning the previous sticker.

**THE CAR PARKING STICKERS WILL BE ISSUED ONLY TO THOSE MEMBERS WHO HAVE PAID SUBSCRIPTION AND CLEARED ALL OTHER DUES OF SCBA.**
