## **NSDL** e-Voting system

- 1. In view of the unprecedented outbreak of COVID-19 pandemic, social distancing has become a norm. Pursuant to the Circular No. 14/2020 dated April 08, 2020 and other directives thereafter issued by the Ministry of Corporate Affairs, physical attendance of the share holders/Members to the EGM/AGM venue is not required and can be held through video conferencing (VC) or other audio visual means (OAVM). Taking a cue, most of the entities like clubs and associations which are otherwise not governed by the Ministry of Corporate Affairs but are governed by their own rules and byelaws also now use e-voting platform of NSDL.
- 2. National Securities Depository Limited (NSDL) is authorised by the Ministry of Corporate Affairs (MCA) as an agency for setting up an electronic platform to facilitate voting in electronic form for meeting/elections. The NSDL is now the leading service provider for e-Voting with commendable track record of fair and secure e-Voting with absolute integrity of results.
- 3. NSDL is the largest securities depository having over 91% share of custody of dematerialized securities in India with total value of securities held of about US \$ 3096 billion (₹227 lakh crore). After NSDL launched its e-Voting system in 2012, the e-Voting facilities are now fairly evolved with approx. 15,000 number of e-Voting events conducted by NSDL. The e-Voting is now popular with large number of Companies/Associations/Clubs which regularly use e-Voting facilities of NSDL for benefits of their stakeholders/members. A list of leading PSUs, Corporates, Clubs and Associations which use NSDL platform for e-Voting is enclosed.
- 4. The members can access the e-Voting system at <a href="https://www.evoting.nsdl.com">https://www.evoting.nsdl.com</a> and log in through user Id and One Time Password (OTP) to be communicated via registered email and/or mobile number to the eligible voter members to cast vote on the polling day already announced i.e. 27.02.2021 (10:30 AM to 6:00 PM). Apart from convenience of home/office, the safety, security and integrity of voting is ensured by protected systems which cannot be tampered.
- 5. Members can click the lock icon in the Address bar to see more information about the security of the website. The e-Voting system of NSDL since its inception has been complying with all the security requirements has the requisite certifications for Information Security ISO 27001, Business Continuity BS 22301 and CQW from STQC for Software Quality AND User Experience to ensure Quality of e-Voting
- 6. The steps for e-Voting are explained hereafter. The members are requested to go through carefully the attachments to understand e-Voting to avoid glitches on the voting day.
