## **CIRCULAR**

Respected Members are informed that Executive Committee of the Supreme Court Bar Association in its meeting held on 06<sup>th</sup> March, 2023 has decided that there will be a Special General Body Meeting to be held on **Thursday, 16<sup>th</sup> March, 2023 at 4:00 PM** in the Supreme Court Lawns in view of the Requisitions:

- Signed by 235 members for calling urgent General Body Meeting of SCBA;
- Signed by 184 members calling for General Body Meeting to show solidarity with the SCBA President and on the issue of allotment of land for lawyers Chambers.

**The Explanatory note for the Special GBM to be held on Thursday, 16<sup>th</sup> March, 2023 at 4:00 PM in the Supreme Court Lawns, New Delhi as decided by the Executive Committee in its meeting held on 6.3.2023 in view of the requisitions signed by the members:-**

The institution i.e. Supreme Court comprises of the Hon'ble Judges of the Court which are 34 in number at present and the Registry of this Court as well as about 17000-18000 lawyers who are the members of the SCBA who were always considered as equal stakeholders in the institution. The lawyers being in touch with the clients also take care of the interest of the clients in the matter of infrastructure /facilities to be created in the institution. It has been the practice of this Court that the lawyers i.e. SCBA is not part of the decision making to decide how the new infrastructure which is to be created should be shared between two equal stakeholders of the institution. The result being that the Hon'ble Judges and Registry have three auditoriums to use to hold seminars and meetings but the SCBA was not allowed to use even one and only recently one out of the three is made available to SCBA on case to case basis and not as of right. While the Hon'ble Judges have several meeting rooms other

than three auditoriums to meet people or entertain the visiting dignitaries especially from foreign countries who visit to Supreme Court whereas till date there is no place where the Bar can meet the same dignitaries if they make a request to do so. It is common practice whenever the visiting dignitaries come to meet the Hon'ble Judges then invariably they make request to meet representatives of the Bar and due to lack of any place with the Bar the request cannot be entertained. Similarly, when this institution was initially built, a limited number of Chambers were provided for the then Lawyers of the Supreme Court but the growth in the number of Chambers have been nothing compared to the growth in the number of regularly practicing lawyers in the Supreme Court. The result being that the lawyers are waiting for more than 25 years from being allotted chambers. In fact, Appu Ghar land/Additional Building Complex was handed over to the Supreme Court on the basis of the petition filed by the SCBA and after the allotment happening the SCBA was not consulted in its utilisation and majority of the constructed area i.e. more than 90 percent of the constructed area was reserved for the Registry and the Hon'ble Judges and remaining 10 percent of the area apportioned for the lawyers of the SCBA comprising of being 234 chambers which was also constructed without consulting the SCBA resulting in size of the chambers being little small for double allotment and big for single allotment. Even the area has been declared as High Security Zone with the result that ingress and egress of the lawyers to the area has been a constant source of harassment to the legal fraternity.

The SCBA has not been given any space in the proximity of the Court in the last 32 years and the last Library-II was given in the year 1991 and whereas membership of the Bar has gone up many fold since then and the Courts are getting cramped and the corridors are full of people for lack of waiting space. The lunch room which has been given to us is a very small cramped room where the members have to wait to have lunch and going in and coming out of the lunch room is also a problem. The Ladies Bar Room is also overcrowded and the corridors of the Supreme Court being not air conditioned, members of the Bar waiting for their matters either crowd inside the Court Rooms or crowd in the Bar Rooms which are proximate resulting in the overcrowding everywhere. The Bar has been raising a demand for more space and for that reason the space in Annexe Building

(Opposite Court Room No.10) was requested to be given but till date even that request is pending.

Another piece of land measuring 1.33 Acres was allotted to the Supreme Court in which it was agreed that 40 percent would be used for the construction of chambers and the balance would be for Archives of the Supreme Court. Our last EC of SCBA took up the said matter with Hon'ble Mr. Justice N.V. Ramana, the then CJI, who orally agreed that the entire building could be given for construction of lawyers chambers but he said that the same cannot be done without the permission of the Government because percentage of 40% allocation was done by the Government. In the tenure of Hon'ble Mr. Justice N.V. Ramana, the then CJI, plans were prepared for the construction of Chamber in the 40 percent and about 200 chambers would have been constructed in the said 40 percent land. The SCBA considering growing need of the members of the Bar decide to file the Writ Petition which got listed before the Hon'ble Mr. Justice U.U. Lalit, the then CJI who issued notice in the matter, and the matter was next listed on 03.11.2022 when the Ld. Attorney General for India appeared. On that date of hearing Hon'ble Mr. Justice U.U. Lalit, the then CJI made oral observation that it would be advisable that the entire building be used for lawyers as multiple use has security issues and moreover the archives can be easily accommodated in the Additional Building Complex where large amount of area is lying vacant. The Ld. Attorney General for India took time to have more detailed deliberations on the issue. Since then, Hon'ble Mr. Justice D.Y. Chandrachud, the Chief Justice of India took charge and the matter has been listed six times and was not heard even once and it has been mentioned before the Hon'ble CJI four times to ensure listing and hearing and no special privilege is being claimed by the Bar. In this background, the 4<sup>th</sup> mentioning of 2<sup>nd</sup> march 2023 took place before the Hon'ble Chief Justice of India. The members of the Bar are extremely perturbed by what happened that day and have asked for a General Body Meeting signed by 184 members for considering the resolution at Sl.No.A and second resolution signed by 235 members regarding the apology tendered by Senior Members of the Bar without knowing the issue and without consulting anyone in the EC of the SCBA and the said resolutions are at Sl.No. B and C below:

By now, all of us are aware of the mentioning made by the President, SCBA alongwith the Executive Committee in Court Room No. 1 of the Hon'ble Supreme Court of India with regard to urgent and immediate listing of the petition seeking a direction to the Ministry of Urban Development to convert the entire land measuring 1.33 acres that was allotted to the Supreme Court into chambers blocks for lawyers. The President, SCBA submitted before the Hon'ble CJI that *"The matter has been listed 6 times and not taken up and mentioned 3 times. The Appu Ghar land came to the Supreme Court on a petition by the SCBA and the bar was given only one block with reluctance and now the land on which 40% was to be used for chamber construction was to begin during CJI Ramanna's tenure and got deferred because we wanted the entire land to be for chambers and our petition is pending and not being taken up for hearing."*

For more than 20 years members are waiting for the Chamber. The President, SCBA a man with strong conviction and commitment towards the cause of betterment of the Bar, has consistently raised this issue, but the matter does not get listed or if listed, does not get heard. Despite our President and the Executive Committee standing tall for the cause, few of the members of the Bar by not supporting and instead taking a contrary stand have brought disgrace to the unity of the advocates' community.

Thus, we, the Members of the Supreme Court Bar Association, hereby strongly condemn the statements made by Shri. Kapil Sibal, Senior Advocate and Shri. Neeraj Kishan Kaul, Senior Advocate, for trying to dilute the efforts of the Executive Committee headed by the President.

The actions of the aforesaid members should be highly condemned and an un-conditional apology ought to be tendered by both the members along with strict actions be taken against them in order to protect the larger interests of the bar and ensuring that no such instances by any other members against the larger interests of the bar are taken on any future occasions.

We the Members of SCBA hereby call upon you to call an urgent General Body Meeting of the SCBA to take necessary action against the abovementioned 2 Senior Advocates for acting against the interests of the members of SCBA.
