CIRCULAR


Respected Members,

UPON hearing the counsel the Court made the following
O R D E R

1. On an oral mentioning being made by the Committee constituted by this Court vide order dated 04.03.2024, we have heard Dr.Adish C.Aggarwala, Senior Counsel and the President, Supreme Court Bar Association (SCBA) as well as the Secretary and officer bearers of the Association. S/Shri Shekhar Naphade and V.Giri, who are the Members of the Committee, are also present. Similarly, Mr. Vikas Singh, the former President of the Supreme Court Bar Association, has also assisted us.

2. There is no ambiguity in para 3 of our order dated 04.03.2024 and we reiterate that all the valid representations/requisitions, i.e., which are signed by 150 such members of the Supreme Court Bar Association, who have the right to cast vote as per the Electoral Roll of 2023, shall be scrutinised by the Committee of three Senior Advocates and shall, thereafter, be placed before the Special General Meeting. On the recommendations made by the Three Members Committee, the Honorary Secretary of the Supreme Court Bar Association is directed to convene the Special General Meeting of the Bar Members on the date and time to be fixed by the Committee.

3. The Resolution to be passed in the Special General Meeting on each such requisition/representation shall be subject to the outcome of these proceedings. The requisitions to be considered in the above-stated meeting shall be those received on or before 16.04.2024 by 5.00 P.M.

4. Keeping in view the fact that the date for submission of requisitions/representations has been extended, the Members of the Committee state that the earlier agenda, prepared by them for consideration of the General House, stands recalled and a fresh agenda shall be circulated.
