Upgradation of SCBA Office Software

The matter has been forwarded to the Secretary General to take appropriate action.

On our visit to the Additional Building Complex along with the Registrars on May 31, 2023, we have identified several issues which require immediate attention and unattending the same may result into serious adversities:

- 1. Due to the inconvenience faced by the members while traveling through tunnel towards the chamber block because of its long passage, a complimentary shuttle service (Golf Cart) and Travelators along with the identification and development of additional short and direct passage towards Chambers block.
- 2. Proper signages need to be marked/painted in the Additional Building Complex as members and visitors gets confused due to lack of signages.
- 3. Requirement of seating arrangements and drinking water in tunnel upto the chamber blocks for advocates and other visitors, particularly for the elderly persons, which may be highly needed in case of emergency.
- 4. Requirement of proper air circulation / ventilation in the corridors and restrooms of chamber block, causing an unpleasant and suffocating environment due to heat and odour.
- 5. Requirement of mirrors, cleanliness in toilets and corridors of Chamber Blocks, Additional Building Complex. Further, requirement of taps/faucets outside the restrooms for the purpose of hand wash and dispensing drinking water.
- 6. Closed/locked several emergency exits in Chamber Block, Additional Building Complex which may result in to high casualty in case of emergency.
- 7. Mobile network in the parking area in basement of Additional Building Complex is poor, which may result into serious mis-happening in case of emergency.

Therefore, you are requested to issue necessary directions to the concerned officials to take note of the aforementioned issues and pursuant take needful steps at the earliest.

I am writing to discuss a matter of disparity regarding the service and maintenance charges levied on the chamber allottees.

As it stands, I have noticed a significant discrepancy in the service and maintenance fees between the Old Chambers Blocks and the D Block of the Additional Building Complex. Currently, the charges for the former are Rs.13,680/-, whereas the latter is levied with a higher fee of Rs.16,848/- This results in an additional burden of Rs.3,168/- for the chamber allottees of D Block.

Such differentiation, it appears, leads to a disparity that might not be equitable for all allottees. The question that arises is why such a differential exists, and on what basis these service and maintenance charges are determined.

In light of the above, I kindly request you to issue appropriate directions to the concerned department to reconsider the service and maintenance charges for the chamber allottees of the D Block in the Additional Building Complex and make these charges the same as the Old Chambers Blocks, which is Rs.13,680/-.

Respected Sir,

I am writing this letter in furtherance to our with regard to the following issues discussed by the SCBA Executive Committee with you.

1. <u>Mentioning of Miscellaneous Fresh Matters before Hon'ble</u> Chief Justice of India:

Earlier Miscellaneous Fresh Matters for urgent listing were mentioned before Hon'ble Chief Justice of India immediately upon receipt of the Diary Number in the said case. Now, as per the new Circular dated 28th June 2023 of the Supreme Court of India, the mentioning in Miscellaneous Fresh Matters is permitted only after completion of the verification process by the Registry. As you are aware, there is no fixed timeline for completing the verification process. There is a considerable delay in verification process of a large number of matters. Due to this, the process of urgent mentioning of Miscellaneous Fresh Matters is getting delayed which is causing great inconvenience to the litigants and member of the Bar. It also delays the listing of the matters.

Therefore, we request you to kindly permit mentioning of all matters upon assigning of the Diary Number or, in the alternative, after registration of the matter i.e. upon receiving the Special Leave Petition Number.

2. <u>Mentioning of after notice and regular matters before</u> <u>concerned Benches of Hon'ble Judges of Supreme Court:</u>

As per past practice, oral mentioning of after notice and regular matters pending before a concerned Bench was permitted directly before the concerned Bench. The procedure has now been changed by Circular dated 28th June 2023 and at present a matter pending before a particular Bench, can be mentioned only uponsubmitting submission of mentioning proforma alongwith letter of urgency before the Mentioning Officer.

Therefore, we request you to kindly permit oral mentioning of all after notice and regular matters pending before a particular Bench without prior submission of mentioning proforma alongwith letter of urgency.

3. <u>Issues pertaining to new E-Filing Portal</u>:

There are several issues faced by the bar members in operating the E-Filing Portal. Main issues are:

- Defects not reflecting in the e-filing portal even though the defects are marked by the dealing assistance. Due to this the 'cure defects' option is not activated and defects cannot be cured in timely manner.
- ii. After defects are cured by a concerned AOR, there is considerable delay in the time taken by a dealing assistance to verify the same and upload any further defects. Hence curing / re-curing of defects re-notified is difficult unless one chases the dealing assistant in person.
- iii. There is no option for payment of deficit court fees. Further; physical payment of the deficit court fee is not reflected in the system in timely manner. This delays curing of defect process as well as the registration and verification process.
- iv. Unable to locate documents filed through new e-filing portal.

It is also noticed that dealing assistants themselves are not fully trained to operate the new e-filing portal therefore resolution of issues is further delayed. Further, on daily basis there are new technical glitches in the new portal which should be rectified immediately for smooth functioning of the e-filing portal.

We request you to kindly resolve the issues pertaining to e-filing portal and also circulate a walk-through video and a standard operating procedure which can explain the working of the e-filing portal in a simple manner for the benefit of the Bar.

4. Delay in listing of matters:

The Supreme Court website does not give a proper indication on when a particular matter is going to be listed. Often the tentative date reflecting on the website keeps changing and Advocates have to chase the listing branch on daily basis for listing of their matters which should have been listed in a routine and systematic manner. We request you to kindly look into the adhoc pattern of listing and organize the same at the earliest to reduce difficulties faced by the litigants and members of the Bar.

We request you to kindly process these requests on an urgent basis.

Letter dated 08.08.2023 regarding renovation of areas inside Supreme Court Compound and Chamber Blocks.

<u>Sub:</u>Renovation of areas inside Supreme Court Compound and Chamber Blocks.
Sir.

I am writing this letter pursuant to the visit with the Hon'ble Chief Justice of India to review areas inside Supreme Court Compound and Chamber Blocks. In this regard, we request to kindly provide a update on the following issues highlighted to the Hon'ble Chief Justice of India:

1. Entry point at Gate-D of Supreme Court.

As requested, there needs to be a separate entry for ladies and gents. First of all, as the security entry point is very narrow, at a time only one person can pass through the security. Therefore there is a need to have 2 security entry points. Further, there is no separate security entry queue for ladies, hence ladies queue is held up.

2. Entry point of the high security zone near R. K. Garg Chamber Block.

- The entry room through which the proximity card holders and daily pass entries are permitted, is in a run-down state. The wires in the said room are exposed and the entries are congested.
- ii. Air conditioners are not working.

iii. The area where ladies are frisked is also clogged and disorganised.

Therefore this area needs urgent renovation.

3. Areas in and around Setalvad Chamber Block.

- i. The exit gate at the back end of Setalvad Block needs to be widened. Presently, it is very narrow and congested.
- ii. Canteen needs to be renovated and modernised. Also, a separate area, platform outside the canteen, may be allotted for running a coffee house (existing CCD).
- iii. The reception area needs renewal at the earliest. The area is not getting utilised as it is unusable.

4. Areas in and around Daphtary Chamber Block.

- Right of way (only for pedestrians use) from Daphtary Chamber Block towards Supreme Court may be permitted through Indian Law Institute. You may kindly consider construction of an overbridge.
- ii. The ground floor and basement of Daphtary Chamber Block are not connected internally. Therefore, a provision for staircase from ground floor to basement from near the lift area needs to be created urgently.
- iii. In the canteen, there is no provision for chimneys. Also, gas pipeline needs to be provided for, right now the gas cylinders are being used which is hazardous.
- iv. Area behind the Chamber block is currently unused. The same may be converted into open badminton courts.
- There is a lot of clutter / litter in the area outside M.C. Setalvad and C.K. Daphtary Blocks. The said area needs to be put in order and beautified.

We request you to kindly process these requests on an urgent basis.

As per the new guidelines dated 17.07.2023 for designation of Senior Advocates issued by the Hon'ble Supreme Court, any person below the age of 45 years, is required to seek a letter of recommendation from a sitting Judge of the Supreme Court or the Hon'ble Chief Justice of India.

There are a number of candidates below the age of 45 years who had applied almost a year ago. At that time, these Rules/Guidelines were not there. These applications have been pending for over a year. Those candidates, whose applications were already pending prior to the coming of the new Rules, should not be required to seek any recommendation letter as they have applied almost a year ago when the said Rules was non-existent.

Given the deadline for such applicants to file an updated form is 19.08.2023, I would request Your Lordship to instruct the Registry to issue a clarification that such applicants who had applied over a year ago when the Rules were not in existence, are not required to obtain the said Recommendation Letter. It may be clarified that this Rule would be applicable to applicants who are applying for the first time pursuant to the new Rules.

The current policy is unfair to mediators because it only compensates them after they have successfully completed two cases. This means they might not receive payment for their hard work and expenses if cases do not settle. Additionally, new mediators must handle at least five cases before receiving compensation for their first one, and they only receive an incentive after completing two successful cases. This setup makes it difficult for them to receive fair compensation for their efforts.

I strongly urge the MCPC to review and amend Office Order 05.01.2024 so that all mediators are fairly compensated for their work, regardless of the outcome of each case. By addressing this issue, the MCPC can ensure fairness in the mediation process and demonstrate their appreciation and support for our mediators.

AUDIT NOTE IN CONNECTION WITH STATUTORY AUDIT OF SUPREME COURT BAR ASSOCIATION FOR FINANCIAL YEAR ENDED 31* MARCH 2024

A. STATUTORY AND LEGAL COMPLIANCES

1. Income Tax Act, 1961

- a. The approval/order granted under section 80G(5)(iv) is valid upto A Y 2026-2027 vide order dated 04/04/2022, URN AAFTS1715BF2021001. Association has been granted registration u/s 12 AA of Income Tax 1961 vide certificate No S- AAFTS1715BE20212 valid upto Assessment Year 2026-2027
- b. All deductions and compliances under chapter XVII B are being made on a timely basis.

2. ESI and P.F

- a. The association has neither taken registration under ESIC act nor any amount has been deducted out of payments to employees/contractual labour. Therefore, no contribution to ESIC fund has been made by the association.
- b. In case of Provident fund, liability has been duly deposited with the authorities.

3. Pending Court Cases/Grant in Aid/Other Laws

- a. Legal cases are pending in various courts. Liabilities for these cases have not been ascertained, pending final judgment of the Court.
- b. A Grant in Aid received from Government of India in the year 1999-2000, for the purpose of construction of Golden Jubilee Auditorium to mark the Golden Jubilee celebration of Supreme Court of India. The construction of the auditorium has not been commenced and the said grant money has been put into the fixed deposits (with scheduled bank) and interest earned thereon has not been considered as income instead has been added to the original amount of the Grant and treated as a liability. The grant including interest amounts to Rs 5,80,25,317.00

 Ministry of Law and Justice (Department of Legal Affairs) vide its letter No F. No. B. 13017/4/199-Admn III (LA) Dated 04.07.2019 had sought information regarding the utilization status and the amount pending utilization as well as, in case of a change in the purpose of utilization, a detailed estimate of such proposal which SCBA wants to undertake. As informed to us, SCBA is pursuing this matter with the Government of India, for the permission for change in purpose for the utilization of said grant.

B. Review of Ledger Accounts

1. Earmarked Funds, Financial Aid Funds And Donations

Funds/Donations/Grants received by the organization for specific purposes, which were partly used or not used during the financial year or outstanding from previous years, are retained as earmarked funds. However, there are many grants that have been unutilized since many past years, which should be transferred to the corpus fund of the society.

Financial Aid, Donations & sponsorships to support specific members and staff members and activities other than earmarked funds alongwith any associates expense, if any, have been shown in Income & Expenditure account.

The organization gives financial aid to its needy members and their families and needy employees. The donations received and donations disbursed have been shown in Income & Expenditure account. During the year, the organization has also donated its shuttle bus (vehicle) to another charitable organization, depreciated value of this bus has been reduced from Capital Fund and Fixed Assets as it was acquired through a specific donation.

2. Fixed Assets

Fixed Assets are stated at cost of acquisition or construction less accumulated depreciation/amortisation and impairment losses, if any. Cost includes material cost, inward freight, taxes and expenses incidental to acquisition and installation, up to the point the asset is ready for its intended use. Borrowing costs during the period of construction is added to the cost of eligible assets. Capital Work in Progress is recognized to the extent of advance payment, in case of partial delivery of assets. Assets given as donation to other institutes has been shown as deletion in Fixed Assets schedule.

Additions during the year have been vouched by a verification of the vouchers maintained and authenticated by the concerned officials.

Physical verification of assets is the responsibility of the management. According to the information and explanations given to us, no material discrepancies were noticed on such verification.

3. Gratuity and Leave Encashment

06/05/17

We have been informed that gratuity and leave encashment are paid to the employees at the time of retirement and accounted for on cash basis. No provision has been made in respect of gratuity and leave encashment due to the employees of SCBA.

In compliance to AS 15, actuarial valuation should be carried out and provision of liability for gratuity should be accounted for in respect of all its employees and disclosure be made in notes to accounts.

4. Sundry Creditors for Goods & Services & Sundry Receivables

Creditors for goods & services included some vendors whose payments are unpaid since more than 2 years, balances not payable anymore due to reason whatsoever have been written off in the books of accounts and stated as Balances written off under Schedule 14, Other Income. Certain amounts were standing as recoverable from members and other vendors since more than 2 years, which were irrecoverable have been written off in the books of accounts and netted off with Balances written off for amount not payable, as above, shown under Schedule 14, Other Income.

5. Court Costs

The Association has received court costs – awarded by the Supreme Court – on various occasions during the year. During the year, the Association received Rs 21,23,375.50/- as court costs for advocate welfare and library upgradation. Court cost received for advocate welfare has been shown as income in the income and expenditure account and been utilized for the administrative expenses and advocate welfare schemes of the Association. Court cost received for library upgradation has been shown as earmarked funds.

8. Internal Controls

We suggest SCBA to strengthen the internal controls system in respect of following areas:

- a) Digitization of amounts due & received from members on various accounts including annual subscription fees etc and integration of such records with the accounting software. Regular verification of list of amount due from members.
- b) Vouchers & cheques should be consistently & mandatorily generated/printed through the accounting software to improve manpower cost & establish internal controls. Cheques to be prepared only after obtaining approval of the designated officer. Digital payments must be promoted and cash receipts and payments must be stopped.
- c) Digitization of data base of each member of the association especially PAN of each member to ensure compliance with the various provisions of the Income Tax Act, 1961.
- d) Financial support in the form of loans was granted to the needy members as part of Covid 19 relief measure. A sum of Rs 235,000/- is outstanding on account of such loans since the year ended 31.03.2024.
- e) An advance of Rs 4,00,187/- is pending with The Oriental Insurance Company Ltd, efforts should be made to recover the same.
- f) The organization must endeavor to increase its charitable expenditure to fulfill the requirements of Section 11 & Section 12 of the Income Tax Act 1961.
- g) The organization must apply for a certificate of lower deduction of tax from its interest income to avoid blocking of funds as TDS under the Income Tax Act 1961.

h) A detailed analysis of applicability of Goods & Service Tax must be undertaken to ensure

compliance

- Donation received in kind must be duly documented and supported with invoices and donation receipts from/to donors.
- j) Proper records should be maintained for fixed assets, library books and other assets and a record for the movements must be created, including digitisation of fixed asset register and periodic physical verification and reconciliation of fixed assets alongwith using a barcoding system for allocating a unique identification number.
- k) Audit of Library books to ascertain lost and mutilated books. Periodic physical verification of the books is needed to ascertain the actual number of books/documents in the possession of the library. Digitization of library books, records, information and ease of access of information by members is required.
- Access controls, revenue generation & recognition from facilitation of cubicles, libraries and other facilities, including maintenance of logs of unpaid facility usage charges & stopping the issue of manual receipts for any service by the organization. Prepaid cards along with smart access controls can be implemented to check any revenue loss.
- m) At present, accounting system being followed is hybrid. License fees, Commission and Bank interest are accounted for on accrual basis and income other than the above on cash basis. Expenses have been accounted for on mercantile basis. Method of accounting must be changed to either cash basis or mercantile basis of accounting
- n) The Association accepts security deposit from its members for use of library books. A reconciliation of security deposit should be carried out to ascertain security deposit liability as on date. Amount received from non-existing members should be either written off or returned.

SIGNIFICANT ACCOUNTING POLICIES

1. The accounts are prepared on a going concern basis as per the historical cost convention.

2. Recognition of Income & Expenses

- a. Income from License Fees, Commission and Bank Interest are accounted for on accrual basis.
- b. All other incomes are accounted for on receipt/cash basis.
- c. Expenses are accounted for on accrual basis.

3. Fixed assets

Fixed assets are stated at cost less depreciation. Cost includes original cost of acquisition including incidental expenses related to such acquisition and installation. Fixed Assets are recognized as assets after delivery of the assets. Capital Work in Progress is recognized to the extent of advance payment given upon fulfillment of part/stage wise delivery conditions.

4. Depreciation

Depreciation on all fixed assets is provided on written down value method at the rates and in manner prescribed under Income Tax Act 1961 and the rules made there under. Depreciation on assets purchased through specific donation has been charged from the date they were put to use. Depreciation on such assets has not been charged to Income & Expenditure account; instead it has been set off against the donation received specifically.

5. Accounting for donation and financial aid

Donations and court cost received for specific activities are accounted for under head "Capital Funds" or Earmarked Funds and shown in the Balance Sheet.

Donations and financial aids received to support specific members, staff members and activities other than earmarked funds, along-with associated expenses, if any, have been shown in Income &

NOTES TO ACCOUNTS

- 1. The additions to the fixed assets during the year have been physically verified. Fixed assets are stated at cost less depreciation and includes original cost of acquisition including incidental expenses related to such acquisition and installation. Discrepancies, if any, have been appropriately dealt with in the financial statements. Assets given as donation to other institutes has been shown as deletion in Fixed Assets schedule. During the year, the organization has received delivery of a software which is under test run and additional features are still being added, hence it has been recognized as a capital work in progress till all required features are added.
- 2. Creditors for goods & services included some vendors whose payments are unpaid since more than 2 years, balances not payable anymore due to reason whatsoever have been written off in the books of accounts and stated as Balances written off under Schedule 14, Other Income. Similarly, receivables were standing in the books of accounts since more than 2 years, balances irrecoverable due to reason whatsoever have been written off in the books of accounts and stated as Balances written off under Schedule 14, Other Income.
- Contingent liabilities not provided for in respect of:
 Legal cases are pending in various courts. Liabilities for these cases have not been ascertained, pending final judgment of the Court.
- Gratuity and leave encashment is paid to employees at the time of retirement and accounted for on cash basis. There is no accounting policy for provision in respect of accrual of gratuity and leave encashment liability.
- 4. An embezzlement of cash committed by some employee of Association came to the notice of Executive Committee during 2006-07. The matter is under police investigation and prosecution and pending final judgment of the Hon'ble Court.

5. A Grant in Aid received from Government of India – in the year 1999-2000, for the purpose of construction of Golden Jubilee Auditorium to mark the Golden Jubilee celebration of Supreme

The construction of the auditorium has not been commenced and the said grant money has been put into the fixed deposits (with scheduled bank) and interest earned thereon has not been considered as income instead has been added to the original amount of the Grant and treated as a liability.

Ministry of Law and Justice (Department of Legal Affairs) vide its letter No F. No. B. 13017/4/199-Admn III (LA) Dated 04.07.2019 had sought information regarding the utilization status and the amount pending utilization as well as, in case of a change in the purpose of utilization, a detailed estimate of such proposal which SCBA wants to undertake. SCBA is pursuing this matter with the Government of India, for the permission for change in purpose for the utilization of said grant.

- 6. The Association has not registered itself under the ESIC act and hence no deduction or contribution being made under ESIC.
- Association has been granted registration u/s 12 AA of Income Tax 1961 vide certificate No S-7. AAFTS1715BE20212 valid upto Assessment Year 2026-2027. Association has claimed its income as being accumulated or set apart for specified purposes and therefore not made any provision for income tax (current & deferred) in its books of accounts.
- Previous year figures have been regrouped or rearranged wherever considered necessary and to 8. the extent possible.
