- The Lunch Room, which is next to SCBA Library-II, has also been completely renovated with all basic amenities like Refrigerator, Utensils, Hot Case/Oven, Display Board, Wash Basin and a Geyser.
- The Air-Conditioner in old Consultation Room near Court No. 4, which was not working, a new A.C. has been installed by the Registry.
- The Hon'ble Judges Pantry under Court No. 6 and 7 has been taken over by the SCBA and converted into 2nd Additional Ladies Bar Room with two more washrooms.
- As there is lack of Centralized Air Conditioning and proper ventilation in 'D' Block, lawyers Chambers Block, Additional Building Complex, Supreme Court. The Registry has now finalised the tenders for Centralised Air Conditioning and it will become operational at the earliest.





The current policy is unfair to mediators because it only compensates them after they have successfully completed two cases. This means they might not receive payment for their hard work and expenses if cases do not settle. Additionally, new mediators must handle at least five cases before receiving compensation for their first one, and they only receive an incentive after completing two successful cases. This setup makes it difficult for them to receive fair compensation for their efforts.

I strongly urge the MCPC to review and amend Office Order 05.01.2024 so that all mediators are fairly compensated for their work, regardless of the outcome of each case. By addressing this issue, the MCPC can ensure fairness in the mediation process and demonstrate their appreciation and support for our mediators.

UPON hearing the counsel the Court made the following O R D E R

1. In continuation of order dated 23.04.2024, the Observer

Committee, constituted by us, has submitted its report. As per the said report all the eight resolutions put up before the Supreme Court Bar Association, Special General Body Meeting held on 30.04.2024 have failed for want of $2/3^{rd}$ majority of the members present and voted. The brief description of all the resolutions has also been given in its report by the Committee. The resolutions inter alia recommended:

- (i) That previous resolution dated 15.10.2014 resolving that no member of the Bar shall be eligible to hold any one post for more than four years in his/her life time should be recalled;
- (ii) That the eligibility conditions to contest for the post of Office Bearers of SCBA, including the length of practice at Bar and the fee to be deposited should be revised;
- (iii) That the admission fee for the members in SCBA should be amended and revised.
- (iv) That the deposit fee and eligibility for candidates to contest for various posts in SCBA Executive Committee be revised and suitably enhanced.
- (v) That the admission fee for the membership for SCBA in future be suitably revised and enhanced.
- (vi) That the requirement of existing number of 150 members for convening General Body/Special General Body Meeting be increased to 600.
- (vii) That the tenure of the Executive Committee be increased to two years as against one year.
- (viii) That there should be reservation for women in SCBA Executive Committee.

- 2. All the aforesaid resolutions/recommendations, each signed by 150 eligible members, have been rejected in the Special General Body Meeting held on 20.04.2024.
- 3. In this regard, we have heard various senior members/members of the Bar. We are of the view that the SCBA is a premier institution and is an integral part of the highest judicial forum of the country. The norms, eligibility conditions, membership, membership fee structure etc., cannot remain static for decades and timely reforms to meet with the challenges that may confront the institution from time to time, are required to be carried out. However, such reforms need to be brought after due consideration of the suggestions from the members of the Bar. In fact some suggestions have been invited from the members of the Bar, including the office bearers of the Supreme Court Executive Committee vide our order dated 14.08.2023. The relevant part whereof reads as follows:
 - "1. In deference to the previous orders including dated 10.07.2023, Mr. Vikas Singh, learned senior counsel has given certain suggestions.
 - 2. Copy of the same be given to Dr. Adish Aggarwala, learned Senior Advocate and President of the Supreme Court Bar Association.
 - 3. We have impressed upon Dr. Adish Aggarwala and the other members of the Bar Association to submit their respective suggestions and/or the modalities to be followed for further reforms in the election process of the Bar Association. The suggestions may be submitted within eight weeks.
 - 4. Post the matter on 30.10.2023."

4. We, thus, direct that:

(i) The Executive Committee of the SCBA shall invite suggestions from all the members of the Bar through a public notice in its

- website. All such suggestions may be invited by 19.07.2024. Such suggestions may be in digital form or through hard copy.
- (ii) Some of the suggestions which have already been brought by senior members/members of the Bar will also taken as part of those suggestions.
- (iii) The Executive Committee of the SCBA shall compile all the suggestions received from members of the Bar and place it on record. Such suggestions will also be then displayed on the website inviting cross-suggestions, if any, which shall be received by 09.08.2024.
- 5. We propose to give a time bound audience to some of the members of the Bar in representative capacity before taking a final call on the suggestions that may be received.
- 6. We are, however, of the view that notwithstanding any resolution passed by the Special General Body of SCBA, some of the posts in the Executive Committee must be reserved for women members of the Bar. We, accordingly, direct that hitherto including for the ensuing election there shall be reservation for women members of the Bar to the following effect:
- (i) Minimum of $1/3^{rd}$ seats in the Executive Committee i.e., 3 out of 9.
- (ii) Minimum $1/3^{rd}$ out of the Senior Executive Members i.e., 2 out of 6.
- (iii) At least one post of the Office Bearer shall be reserved for women candidate exclusively by turn and on rotation basis.
- (iv) In the ensuing election for 2024-2025, the post of Treasurer of the Executive Committee is reserved for women.

- 7. Though no clarification is required, however, to remove any sort of doubt, it is made clear that reservation is only to guarantee a minimum and women members of the SCBA, subject to their eligibility, shall be entitled to contest the election for all the posts in the Executive Committee.
- 8. We have also considered the suggestions and modalities for conducting the election of the Executive Committee of the SCBA, which will become due to expiry of the term of the current office bearers on 18.05.2024. In this regard, after considering the view point of various members, it is directed that:
- (i) The election of the officer bearers of the SCBA and the Executive Committee shall be held on 16.05.2024.
- (ii) The election shall be held on the basis of the voter list as was finalized in the election for the year 2023.
- (iii) Apart from those under the voters list for 2023, all those members who have become eligible between 01.03.2023 to 29.02.2024 would also be entitled to be included in the voters list. In this regard, we have been informed that a communication dated 06.03.2024 has been sent to the Supreme Court Registry for providing the following details:
 - (1) Data of entry of Proximity Card of SCBA Members between 01.01.2023 to 31.12.2023,
 - (2) Updated List of Chambers Allottee,
 - (3) Updated List of Chambers Waiting,
 - (4) Updated List of Amicus Curiae and
 - (5) Updated List of Mediation Panel of SCBA Members.
- (iv) We direct that the Registry shall, if it is not already made

available, make available the above requisitioned list on or before 03.05.2024.

- (v) The counting of votes shall commence on 18.05.2024. The result shall be declared on 19.05.2024.
- 9. The Election Committee shall comprise of (i) Mr. Jaideep Gupta, Sr. Advocate, (ii) Mr. Rana Mukherjee, Sr. Advocate and (iii) Ms. Meenakshi Arora, Sr. Advocate.
- 10. In case, if any of the three members have any difficulty, he or she may mention the same before us for replacement.
- 11. The Election Committee shall be at liberty to co-opt volunteers for conducting free and fair election.
- 12. We make it clear that the decision of the Election Committee shall be final on all aspects, including on the aspect of the eligibility for inclusion in the voters list
- 13. Post these matters on 15.07.2024.

You are requested to kindly take notice of Order VI Rule 6 of the Supreme Court Rules 2013 framed in exercise of powers under Article 145 (3) of the Constitution of India which clearly details categories of cases to be listed during vacations. Order VI Rule 6 of S.C.R. 2013 is reproduced below:

ORDER VI CONSTITUTION OF DIVISION COURTS AND POWERS OF A SINGLE JUDGE

- 6. During the vacation, the Vacation Judge sitting singly may, in addition to exercising all the powers of a Judge in Chambers under these rules, exercise the powers of the Court in relation to the following matters, namely: -
- (1) Applications for special leave to appeal in urgent cases where interim relief is prayed for subject to the condition that the Vacation Judge shall not decide such a petition if it raises substantial question of law as to the interpretation of the Constitution.
- (2) Applications for stay of execution of a decree or order or stay of proceedings in civil matters.
- (3) Applications for transfer of cases under section 406 of the Code of Criminal Procedure, 1973 (2 of 1974).
- (4) Applications for stay of proceedings in criminal matters.
- (5) Applications under article 32 of the Constitution of an urgent nature which do not involve a substantial question of law as to the interpretation of the Constitution.
- (6) Issue of a rule nisi in urgent applications under article 32 of the Constitution which involve a substantial question of law as to the interpretation of the Constitution.
- (7) Applications of an urgent nature for transfer of cases under section 25 of the Code of Civil Procedure, 1908 (5 of 1908).
- (8) Issue of notice in applications of an urgent nature under Article 139A(I) of the Constitution; and

(9) Applications of an urgent nature for transfer of cases under Article 139A(2) of the Constitution.

The abovementioned Circular has been issued in the midst of vacations for listing of cases without the consent of the concerned Advocates-On-Record or the Supreme Court Bar Association. It is noteworthy that the purpose of listing of matters during summer vacations is only limited to hearing urgent matters covered under Order VI Rule 6 of Supreme Court Rules 2013.

Further, it is to state that notices dated 02.05.2024, 15.05.2024, 11.06.2024 and 20.06.2024 have gone beyond the scope of Order VI Rule 6 for listing of matters not covered thereunder.

You may please note that this is causing undue anxiety and hardship to the Advocates-On-Record/ Party-in-person/ stakeholders etc. who are not in Delhi because of summer vacations, least expecting that their cases will be listed through above Circulars/Notices issued in the midst of summer vacations. Needless to say that Advocates-On-Record or other Advocates do not carry the files while being out of station during summer vacations. Thus, they are handicapped in making submissions before Hon'ble Supreme Court even through V.C. when such matters are suddently listed and taken up for hearing.

Large number of A.O.Rs. and other advocates have put forth their grievances to the SCBA Office for onward communication of their hardship to your goodself for taking remedial steps for this unusual and unprecedented listing of cases.

It may kindly be noticed that the List of Business issued for 25.06.2024 has a long list of cases which are bearing "Diary Numbers" i.e. S.L.Ps. filed beyond Limitation and even re-filed belatedly with application for condonation of delay, clearly signifying that there is no urgency involved therein for listing during summer vacation, which run counter to the Circulars/Notices issued on 02.05.2024 and 15.05.2024 i.e., prior to summer vacations.

Regretfully, the Registry has ignored that such matters are to be listed before Hon'ble Chambers Judge and it is only thereafter that such matter are placed before Regular Benches for hearing. Order V Rule 1 Sub Rule (20) and Order V Rule 2 Sub Rule (32) are reproduced hereunder for ready reference:

Order V

Business of Chambers

1. The powers of the Court in relation to the following matters may be exercised by the Registrar, namely:

Rule 1

Sub-Rule (20) Application for condonation of delay in re-filing, provided the delay does not exceed 60 days from the date of notifying the defects.

Rule 2

Sub-Rule (32) Application for condonation ofdelay in re-filing where the delay exceeds 60 days from the date of notifying the defects.

It may be further noted that large number of advocates have reported their grievances that in spite of filing of "Urgent Affidavit" their S.L.P.s are not being listed by the Registry arbitrarily thereby causing concern to the stakeholders.

In view of the above, it is requested that all such matters wherein the consent of the Advocates-On-Record has not been taken and do not fall in the category of cases under Order VI Rule 6 of Supreme Court Rules 2013 be withdrawn forthwith and only urgent cases be listed which are duly supported by affidavit of urgency.

This is to bring to your kind attention that many advocates have approached the undersigned with regard to notices received by their clients pertaining to the Special Lok Adalat, organized by the Hon'ble Supreme Court, scheduled to be held from 29th July to 3rd August, 2024. Many advocates have complained that notices have been sent directly to the clients in the matters which also include; appointment, dismissal from service, payment of gratuity, pension etc. It has been further pointed out by various advocates that matter which are pending before Constitutional Bench, parties have been sent the above stated notices for joining the aforesaid Special Lok Adalat.

Needless to say that settlement before Lok Adalat could be in cases involving family disputes, matrimonial issues, contracts, property disputes, rent cases etc., which could have been identified by the Registry and notices could be sent to those parties only, instead of sending notices in all the cases to the litigants requiring them to participate in the Lok Adalat, so much so that the litigants at local level are receiving telephone calls from the concerned District Court thereby causing anxiety to them. Such situation could have been avoided if the Registry had engaged in some thought process instead of mechanically sending such notices to all and sundry.

It is suggested that in this process the involvement of concerned AOR could have been more beneficial to this Hon'ble Institution as also to all stakeholders.

There are several instances wherein cases are listed on 25.06.2024 before this Hon'ble Court and simultaneously litigants in those cases have been asked to give their consent in the ensuing Lok Adalat thereby creating utter confusion and they are frantically calling their advocates. Such situation could have been avoided if the AORs had been consulted before sending such notices for Lok Adalat to the litigants.
