## REVISED CIRCULAR

- Members are informed that the Annual Cricket Tournament of Supreme Court Bar Association will be organized tentatively from Second Weekend of January 2025 onwards at Modern School grounds, Barakhamba Road, New Delhi and Finals will be played at Arun Jaitley Cricket Stadium, Feroze Shah Kotla, Delhi.
- 2. The Tournament would be played in T-20 format and each team will have a different color uniform.
- In addition to the regular teams which we have for the Tournament, there
  would be teams for members over 50 years of age also in both men and
  women category, if we get sufficient number of entries in over 50 years
  category.
- 4. It is, however, made clear that those over 50 years can participate in below 50 years category or over 50 years category but they can participate in only one category. However, less then 50 years can only participate in less than 50 years category.
- 5. All matches would be played on Saturdays and Sundays or on Holidays. Teams will have to report at ground 45 minutes before the start of the match so that all the matches are finished within time.
- 6. Tournament would be for both Men and Women Category. In both Men and Women category, Senior Advocate can sponsor the team on the payment of Rs.1,00,000/-, by contributing Rs.1,00,000/- by cheque/Demand Draft, in favour of the Supreme Court Bar Association, which will be utilized for making of Uniforms, Cricketing Kit & Booking of Ground, eatables, drinks, fruits etc.
- 7. Senior Advocates sponsoring the team would have choice of his/her captain plus four players who should be Permanent Members of SCBA or has played till last tournament and for Women Team, Captain plus six Lady Members. However, rest of the players in the team would be given by draw of lots by SCBA.
- 8. Also no players would be allowed to be interchanged amongst the teams after the draw of lots on any ground whatsoever.
- 9. Participation fee per member would be Rs.1400/- for the tournament and members interested to participate in the tournament are requested to give a cheque for Rs.1400/- (Rupees One Thousand four hundred only) towards Participation Fee in favour of the Supreme Court Bar Association alongwith their name in the SCBA Office.
- 10. Last date for giving participant fee for the Cricket Tournament is 18.11.2024.
- 11. Further details regarding number of teams and the date of matches and other details would be informed once we get to know the total number of participants.
